#### Annual Business Meeting & Election Scheduled for October 1

The election will be part of the Annual Business Meeting (ABM) for PHCC—National Association which will take place virtually via Zoom on **Wednesday**, **October 1**, at 2:00 p.m. ET. (1:00 p.m. CT /12:00 p.m. MT). All are welcome to attend, but per PHCC Bylaws, ONLY Active and Life members of PHCC are eligible to vote. Introductory members are not eligible to vote. If a member wishes to vote, either by absentee or during the live meeting, they must register to do so.

An email was sent in August to all eligible voting members asking them to register to vote in this year's elections. This email is crucial as it contains the voter registration form, which needs to be filled out for voting live or absentee.

The process will be entirely electronic. Voter registration, the meeting itself, and the voting process (both absentee and live) will all be conducted online.

Non-voting members of PHCC are welcome and encouraged to attend the ABM even if they are not voting. Additional emails will be sent prior to the meeting with more information.

If you have not received an email with a voter registration form, and you believe you are an eligible voter per the above criteria and wish to vote this year, please send an email to ExecutiveOffice@naphcc.org to verify your status.

## PHCC Political Action Committee (PHCC-PAC)

#### WHAT IS PHCC-PAC?

Plumbing-Heating-Cooling Contractors—National Association Political Action Committee is a non-partisan political action committee to support and elect proindustry and pro-business candidates for federal office.

#### WHO CAN PARTICIPATE IN PHCC PAC?

Only individual and non-corporate business members may receive solicitations and participate in PHCC PAC.

PHCC PAC can ask for contributions from executives or those with an ownership stake in a PHCC member



business only after prior written approval has been provided. Only an authorized representative with whom PHCC normally conducts association business may give prior approval. Representatives from our incorporated member companies can use an online form for this purpose.

#### HOW DOES PHCC PAC WORK?

PHCC PAC pools permissible resources from America's plumbing and HVAC contractors. That enables the plumbing-heating-cooling (p-h-c) industry to support candidates for federal office who believe in and support pro-industry and pro-business policies.

#### HOW DOES THE PHCC PAC HELP MEET THE P-H-C INDUSTRY'S GOALS?

Decisions by lawmakers and regulators on Capitol Hill impact every aspect of the p-h-c industry. Federal legislation impacts your day-to-day business operations and affects how plumbing and HVAC products are manufactured and installed. Sound public policy begins by supporting and electing candidates to federal office who understand the p-h-c industry and know that you protect the health and safety of the American people.

#### HOW ARE PHCC PAC CONTRIBUTIONS TO CANDIDATES DETERMINED?

PHCC PAC is governed by a committee of 12 PHCC members and state executives from across the country. The committee convenes throughout the year to determine the best opportunities for PHCC PAC engagement and support.

## Don't Let the Government Plumb Without You

When I got into this trade, I figured I'd be working with pipe wrenches, not politicians. But here I am, telling you that what we do in the halls of Congress is just as critical as what we do in basements and crawlspaces.

Why? Because if we're not at the table, we're on the menu. And I don't know about you, but I prefer eating to being eaten, especially when I've already skipped lunch for the third time this week.



#### Advocacy Isn't Optional Anymore

Every day, government agencies and elected officials are making decisions that directly affect how you run your business – whether it's workforce funding, licensing rules, energy codes, or how you train the next generation. If we don't speak up, we'll be stuck living with decisions made by people who think "sweating pipe" means being nervous.

PHCC gives us a powerful voice – on Capitol Hill, in statehouses, and in regulatory meetings that most contractors never even know are happening. But our voice is strongest when it includes *your* story, your experience, and your boots-on-the-ground knowledge.

#### What We Did in D.C. (and Why It Matters)

At this year's Legislative Conference, we hit the ground running. Contractors from across the country showed up, suited up (yes, some of us even ironed our shirts), and talked to lawmakers about the real-world impact of their decisions.

#### And guess what? They listened.

We weren't just talking points; we were taxpayers, employers, problem-solvers. We made sure they understood that plumbing and HVAC contractors are essential to public health, energy efficiency, and workforce development. Because let's face it: you can't have a green future if nobody knows how to install a tankless water heater.

#### You Don't Have to Be a "Politics Person"

I know what you're thinking: "I've got crews to manage, jobs to finish, and a parts delivery that's been 'almost there' for three hours. I don't have time for politics."

Totally fair. But here's the thing – the people *making* the rules have all the time in the world to affect your business. That's why we advocate. So you can focus on running your company, knowing someone's watching your back.

You don't have to move to D.C. or memorize bill numbers. Just stay plugged in. Support PHCC's advocacy team. Attend a local event. Share your story.

Even five minutes can make a difference, especially if you use those five minutes to explain to a state senator why your apprentices aren't learning to install plumbing systems on TikTok.

## Don't Let the Gov't Plumb Without You continued

#### Real Contractors, Real Impact

Some of our members have taken their advocacy even further – running for local office, joining advisory boards, or helping shape state code updates. And whether they win elections or just win influence, they're making a difference for all of us.

You don't have to go that far (unless you want to – we'll back you up), but their involvement shows what's possible when contractors step into leadership roles. You've got more influence than you think ... and PHCC is here to help you use it.

#### Plumbing Protects the Nation. Advocacy Protects the Industry.

Our work literally keeps the water flowing, the air clean, and the buildings safe. That's something to be proud of. But it's also something worth protecting.

So as your president, I'm asking you to get involved. Be aware. Be vocal. Be the contractor who doesn't just fix problems but helps prevent them in the first place.

Because at the end of the day, policy affects everything from your bottom line to your apprentices' future. Let's make sure those decisions are made *with* us, not *about* us.

Thanks for all you do ... and thanks for letting PHCC be your voice, your shield, and your megaphone.

## Regulatory Report

#### The Treasury Department Seeks Feedback

The Internal Revenue Service (IRS) invites the public to participate in an anonymous feedback survey on tax preparation and filing options, which will run through Sept. 2, 2025. The survey is being conducted as part of the IRS's efforts to fulfill a reporting requirement to Congress under the One, Big, Beautiful Bill Act.

The law directs Treasury to deliver a report to Congress by Oct. 2, 2025, on several key issues related to free tax filing options for the public. Participants may remain anonymous. Visit the Free Online Tax Preparation Feedback Survey.

#### DOT to Recommend Wind Farm Buffer

U.S. Department of Transportation (DOT) Secretary Sean Duffy indicated that he will recommend a 1.2-mile buffer zone between wind farms and railroad tracks. An *E&E News* story explains that DOT has concerns that wind turbines may cause interference with railroad radio transmissions and might affect the positive train control safety system. DOT is basing their decision on the information from a single report from a train industry consultant and has also expanded the recommendation to include highways which were apparently not included in the report. The wind power industry and representatives from the railroads are reviewing this proposal and are expected to provide additional information on this issue.

#### Water Pipe Sizing Part of the Discussion At the PHCC Industry Partner Summit

PHCC convened its 2025 Industry Partner Summit last week at the Chicago O'Hare Hilton. During a panel discussion which concerned water quality and promoting best practices for piping potable water systems, Dan Cole from the IAPMO Group presented information on the revisions to Hunter's Curve. His team's research led to the development of the Water Demand Calculator. Using the new calculator can promote right-sizing of pipes, reduce water residence time, maintain water disinfection, reduce wasted water, and save consumers money on water system installations. #### IRS Issues Guidance on Energy Tax Credits

The U.S. Treasury Department issued guidance **FAQ's** through the Internal Revenue Service (IRS) to explain the coming changes for energy efficiency tax credits. These changes are necessitated by the recent passage of the One, Big, Beautiful Bill Act (OBBBA). While the answers to these questions have not been published in an IRS Bulletin and are subject to future modification, they provide the most current interpretation from the IRS. Taxpayers who have relied on this guidance will not be subject to penalties should future published interpretations change the taxpayer's tax liability. As always, PHCC recommends that individuals and business owners seek professional tax advice for any questions that might arise when dealing with the IRS.

#### ABOUT THE COURSE

#### MEDICAL GAS INSTALLERS TRAINING SEMINAR

A Medical gas installation and brazing class is being set up for Sioux Falls, South Dakota, January 20-23, 2026. Classes will run from 8:00 am to about 5:00 pm. Students will need to bring paper and pencils for note taking and highlighters.

Contractor employees need to be journeyman level, or active in an apprentice program for at least four years. Estimators, construction company officials and hospital employees who will not be installing medical gas systems, and building officials/inspectors, are welcome into the class with the four year requirement waived.

As many of you are aware, NFPA has mandated brazing qualifications since 1993. NFPA 99 now mandates that all installers meet the requirements of the A.S.S.E. series 6010, 32 -hour course. In addition, many major design firms now mandate compliance with the ANSI/A.S.S.E. 6000 series in their specifications. As of July 2016 the federal government has mandated compliance with the 2012 edition of NFPA 99.

Class will consist of training in all facets of medical gas pipeline equipment installation for hospitals, office-based occupancies, nursing homes and other health care facilities. A portion of the class will be devoted to learning proper brazing techniques and requirements for working with medical gas equipment and piping. The textbook for the class will be the 2018 edition of NFPA 99 and will be provided, as well as other learning aids.

Students will also be required to successfully complete a written examination as well as a brazing practical in which you be required to braze vertical and horizontal full-penetration joints on 1-1/2" tubing and the brazing coupons will be tested by a Certified Welding Inspector at an independent laboratory.

Class fees will include the use of turbo torches and acetylene. Each student will need to bring 4' of 1-1/2" L tubing (not cleaned) and 6 to 8 1-1/2" wrought couplings with stops, as well as 1 lb of silver solder.

Class space is limited.



## Another Reconciliation Bill in the Works

House Republicans under Speaker Mike Johnson (R-LA) have been in talks over the summer to draft another reconciliation bill.

#### WHY IT'S IMPORTANT:

Reconciliation in Congress is a means for the majority party to aggregate its budgetary priorities into a legislative vehicle. This is important because the Senate requires 60 votes

(known as "cloture") to debate on any legislation; cloture is not required if the legislation is a reconciliation package. The only caveat is that reconciliation must be tied to federal budgetary items and must exclude any provisions that do not meet that criteria.

#### RECAP:

The One Big Beautiful Bill Act (OBBBA) signed into law on July 4 was a reconciliation package that passed the Senate with a simple majority in the Senate and encompassed top Republican tax and spending priorities. PHCC secured a number of wins in the bill with permanent extensions of higher estate tax thresholds, deductions on qualified business income, and bonus depreciation, and eligibility for Pell Grants to be used for short-term job training programs. On the other hand, OBBBA also sunsets tax incentives for residential and commercial energy efficiency improvements. These items are all tied to the federal budget.

However, the reconciliation process is not a means to secure just any policy priority. For example, PHCC would not be able to use the opportunity for another reconciliation package to push for preemption of gas bans at the state and local level because it is wholly unrelated to the budget process and must therefore be pursued through the traditional legislative process requiring cloture in the Senate.

#### WHAT NOW?

Congressional Republicans may have a tough uphill climb this time around. OBBBA included the bulk of tax and budgetary priorities championed by the Trump administration and conservative political base, yet barely passed on party-line margins in the House while requiring Vice President J.D. Vance to cast the tie-breaking vote in the Senate. The appetite even among House and Senate Republicans is not as strong for a second reconciliation bill that would likely include the 40 or so tax policy priorities that were not addressed in OBBBA.

Furthermore, Congress must not only figure out how to fund the federal government past September 30, it must also consider Farm Bill reauthorization in addition to highway reauthorization and potentially reforming the Energy Policy and Conservation Act. Prioritizing another reconciliation package would further forestall these legislative priorities.

PHCC will monitor developments on a potential second reconciliation package and provide updates when available.

#### Highlights from This Month's Insta-Intel:

Tariffs Are Back in the News

Tariff news has dominated recent economic headlines and tariff rates have increased for several large trading partners. However, the impact of tariffs on price levels is not yet fully visible.

Cracks in the Jobs Market Are Emerging

While the unemployment rate remains low by historical standards, recent growth in employment totals have slowed. Several U.S. regions have seen negative employment growth in recent months, though employment trends for P-H-C businesses have performed better.

- High Rates Continue to Weigh on the Housing Market
  - Betting markets increasingly believe that the Federal Reserve will lower their target interest rate at the upcoming September meeting. Lower short-term rates will benefit the housing market if they lead to a decline in mortgage rates, which remain near 7%.
- Nonresidential Construction Trends Point Toward Cooling Demand The Architecture Billings Index has been in contraction for more than a year, and the weakening project pipeline is becoming visible in current construction data. However, nonresidential segments like data centers continue to see explosive growth.
